Enrollment Procedure

Once you have chosen your course of study, please contact the Admissions Department to set up an appointment for the entrance exam. You will be required to fill out all required enrollment documents after passing the entrance exam. The entire enrollment process will take approximately 2 hours. DMS, CVT, DCS, MRI, NDT, and ST applicants will not enroll on the same day as the entrance exam.

In addition to your completed application, please bring the following items to your appointment:

- 2 forms of identification (driver's license, passport, social security card, employee ID, etc.)
- \$125 administrative fee (nonrefundable)
- Proof of high school diploma, GED, or degree completion.
 - Valid proof includes an original high school diploma, original college degree, and/or official sealed transcript. Copies will not be accepted.
- Current resume (only for programs less than 900 hours)
- Employment Information Form
- Proof of associate degree or higher (DCS applicants only)
- Official sealed transcripts from all postsecondary schools attended (DMS, CVT, DCS, MRI, NDT, and ST applicants only)
- Proof of college-level English, math, physics, and human anatomy & physiology (DMS applicants only)
- Statement of Purpose (MRI applicants who do not have an associate degree or higher)
- 3 letters of reference. Letters must be typed, signed, and specify program of interest (DMS, CVT, DCS, MRI, NDT, and ST)

A physical, including a TB test and up-to-date immunizations, will be due by the first day of class for certain programs. A criminal background check and drug screening are required for enrollment in the Pharmacy Technician program.

If your education was completed outside of the United States, you may be required to provide an evaluation of your diploma/degree. All students who are seeking credit transfers will also be required to submit their official sealed transcripts and/or other relevant documents for evaluation. Please note that certain programs will also require an interview with the school director and/or the program director prior to acceptance/enrollment.
